The Program makes grants only to 501(c)(3) public charities, government instrumentalities (exclusively for public purposes), and operating foundations. In its grant letter,

the Program requires the grantee to commit to use the grant funds exclusively for charitable purposes. Although the Program does not require grantees to submit reports,

if the Program learns of any misuse or diversion of grant funds, the Program will investigate and take appropriate action.
