Individuals and corporations establish and maintain donor-advised fund accounts by making contributions to the Program. Based on donor recommendations, these contributions are invested among six investment pools to potentially grow over time. Donors may recommend that grants be made from donor-advised fund accounts to support qualified public charities, private operating foundations, and governmental entities. The Program for Charitable Giving also educates donors and potential donors about the history of philanthropy, the rewards of charitable giving, and opportunities for volunteering. Information is provided through the Program's newsletter, website, and other printed material.

In accordance with the requirements of the conflict of interest policy, when an individual covered by the policy sees that a Program transaction poses a conflict of interest, that individual discloses the conflict of interest, refrains from attempting to influence the outcome of the transaction, and physically removes him or herself from the discussions and decisions related to the transaction. In the case of conflicts involving board members, the Program for Charitable Giving notes such disclosure and recusal in the board minutes.

The President's compensation is set by the Board of Directors annually after reviewing market data that shows the compensation levels for positions of similar responsibility at similarly situated charitable organizations in the same geographic area. The President's compensation is the decision of the Board of Directors, documented contemporaneously through the board minutes.
